## Rules for the 2024 AVCR-IRHA-FISE-NRHA 4th Show (1 of 2)

### STALL RESERVATIONS

Stall reservations and cancellations must be made officially through the website [www.avcr.it](http://www.avcr.it) BY NO LATER THAN 6:00 PM on Wednesday, July 10, 2024. Beyond this date, availability is not guaranteed.

Stalls are limited and will be assigned in the order of reservation and cannot be assigned if sold out before the end of reservations. Stalls reserved and not canceled by the reservation deadline must be paid for at the participation fee rate (even in case of certifications). Any use of the stalls (for competing horses, non-competing horses, for tack, etc.) requires payment of the full participation fee.

Arrival at the facility is possible from Wednesday, May 8, 2024, at 9:00 AM at the expected participation fee cost.

### PAYTIME

Registrations for paytime (7' each) can be made by phone / SMS / WhatsApp at **+39.329.17.86.555** or email [segreteria@avcr.it](mailto:segreteria@avcr.it) BY NO LATER THAN 6:00 PM on Wednesday, July 10, 2024, or through the show office, indicating the preferred entry time of the pair among those still available.

A 7' paytime per horse is guaranteed (if still available, it's possible to reserve more). However, the secretary reserves the right to modify reservation times and the number of paytimes reserved to optimize the schedule.

Reserved paytimes that are not used must be paid for.

### COMPETITION ENTRIES

Show pre-registrations can be submitted through the website [www.avcr.it](http://www.avcr.it) BY NO LATER THAN 6:00 PM on Wednesday, July 10, 2024, or by sending the form via email to [segreteria@avcr.it](mailto:segreteria@avcr.it).

Pre-registrations are mandatory but not binding and can be changed at the show office before payment.

Additional registrations can still be made through the show office until 5:00 PM the day before the competition (Friday, Saturday, and Sunday). After this time, no further registrations will be accepted.

Entry forms must be filled out and signed by the competitor themselves or a guardian in the case of a minor.

Riders are required to check the start times of the competitions and the timing of the breaks announced on site.

Entries may be finalized via bank transfer (by providing the TRN/CRO) or directly at the onsite secretary's desk. No changes will be accepted after payment has been made.

Back numbers will not be released without confirmation or verification of payment.

Scratches must be communicated before the start of each category, but no refunds will be provided.

Participants not in good standing with their payments to the Association may not participate in the event unless the balance is settled.

All competitors, by registering, agree to comply with the AVCR-IRHA-FISE-NRHA regulations in effect.

The organizing committee assumes no responsibility for any accidents, damages, thefts to riders, grooms, horses, or caused by them to third parties or third-party property. Dogs must be kept on a leash at all times.

Access to the competition area is allowed only to horses that have paid the participation fee.

## Rules for the 2024 AVCR-IRHA-FISE-NRHA 4th Show (2 of 2)

### EARNINGS

**By not attending the award ceremony, you automatically forfeit the trophy and any money earnings.**

Unclaimed winnings can be collected (not reversed from future payments) only until December 31, 2024.

Beyond this date, unclaimed earnings will be considered voluntary donations to the Association.

It is also reminded that **the prize pool is void if there are less than three competitors per category.**

Any earned prizes will be paid at the next stage if registered by check.

### MINORS AND 'A' LICENSE HOLDERS

**Minors** are required **to wear helmets and protective vests when riding throughout the event**, both in the Warm-up and Competition Arenas. **Minors and 'A' license holders (even if adults)**, both in the Warm-up and Competition Arenas, **must be accompanied by a qualified FISE instructor**, who **must sign the form** allowing the rider to compete.

### MEMBERSHIP DOCUMENTATION

At the time of registration, **it is mandatory to present** the **FISE competitive license of the rider** and the **FISE passport of the horse** duly renewed for the year 2024, the **IRHA 2024 membership card of the rider**, and the **IRHA competition license of the horse** updated with any ownership changes. If participating in NRHA competitions, the **NRHA 2024 membership card** of the rider and the **NRHA competition license** of the horse must be presented at registration. Unless otherwise indicated, it is reminded that **horse owners** (when not the riders themselves) must be up to date with the payment of the annual IRHA and/or NRHA membership fee. **It is not possible to issue FISE licenses and passports nor IRHA or NRHA competition licenses and membership cards on-site.** If not in compliance, registration for the competition will not be allowed, with the obligation to fully settle any booked services. Therefore, please **regularize your status in advance** with the IRHA national secretary, which can be contacted at +39.0521.81.91.51 from Monday to Friday, from 8:30 AM to 12:30 PM.

**Horses** must arrive with **regular health certificates**.

Note: In accordance with health regulations in force since November 2006, all horses must be equipped with the **Coggins test according to regional regulations** (in addition to the AIA - FISE Passport and Form 4).

For any matter not mentioned, refer to the IRHA 2024 Rulebook and the NRHA 2024 Handbook.

### DEBUTANTS CHAMPIONSHIP

Registration is possible from the **FISE 'A' license** with exemption from the IRHA membership fee. In fact, **for debutants classes, riders can obtain the IRHA membership card for free** until the acquisition of the FISE BWR license.

However, they must send the request to the IRHA secretary, accompanied by the relevant FISE license.

It is possible to ride **horses not owned by the rider**, provided they have a duly renewed FISE passport.

In the same category, a horse can be shown by a maximum of two different riders.

**It is mandatory to be accompanied by a FISE instructor.**

**Categories are valid for the Debutants Championship** with the final in the following calendar year.
